IV. Discuss Road Maintenance Plan

The Board discussed the need to maintain roads in order to extend their life. They also discussed the need of setting up a road reserve fund to help elevate the need of bonding to fund basic maintenance of roads each year and add to the Towns Debt service.

An example was given a \$1,000,000 bond over 10 years cost the town approx. \$125,000 a month. Bonding \$300,000 and more each year greatly increase the Towns Debt and quickly increases the yearly budget. It was agreed that it would be beneficial to have a fund to pay for basic maintenance and only bond major projects.

There was also discussion on why we would only do a minor shim now on roads if in 3 years we would then do a larger shim? The reasoning is the impact on the budget. Bowdoinham has 30 miles of roads, on a ten-year rotation that is only 3 miles of road redone each year. Doing a small maintenance shim now will help keep the road until more extensive work can be scheduled later and will allow more maintenance work to be done to other roads.
