Maine School Administrative District No. 75 Bond Resolution (\$9,000,000.00)

Voted: That the loan commitment of the Municipal Bond Bank (the "Bond Bank") dated March 15, 2023 to purchase the interest-bearing bond(s) of the Maine School Administrative District No. 75 (the "District") in the original principal amount of up to Nine Million and 00/100 Dollars (\$9,000,000.00) (the "Bonds"), and the same hereby is accepted and approved.

Voted: The Bonds will be sold to the Bond Bank, and shall bear such date or dates, shall bear such interest rate or rates per annum, shall be in such denominations, and shall be issued at such price or prices, all as may hereafter be determined by the Treasurer and the Chairperson of the District, their execution of the Bonds to be conclusive evidence of the District's determination of the terms and provisions thereof.

Voted: That the Board of the District hereby authorizes the borrowing in the amount of up to Nine Million Dollars (\$9,000,000.00) from the Bond Bank on behalf of the District, which borrowing is pursuant to and authorized by the referendum vote of the District voters on March 19, 2022, and all other authority thereto enabling, to fund the construction, repair, renovation and improvement project at Mt. Ararat Middle School, as well as paving and related improvements across the District (the "Project").

Voted: That under and pursuant to the applicable provisions of Title 20-A M.R.S.A., the Chairperson of the Board and the Treasurer be and they are hereby authorized to issue the Bonds, and to execute and deliver the Bonds under the seal of the District, in such form as the Chairperson of the Board and the Treasurer may approve;

and that the appropriate officials of the District be and hereby are authorized to execute and deliver on behalf of the District such other documents and certificates as may be required in connection with such borrowing; and that no part of the proceeds of such borrowing shall be used, directly or indirectly, to acquire any securities and obligations, the acquisition of which would cause the Bonds to be "arbitrage bonds" within the meaning of Section 148 of the Internal Revenue Code of 1986, as amended; and that the Chairperson of the Board and the Treasurer be and they are hereby authorized to covenant on behalf of the District to file any information report and pay any rebate due to the United States in connection with the issuance of said Bonds, to take all other lawful actions necessary to insure the interest on the Bonds will be excluded from the gross income of the owners thereof for purposes of federal income taxation and to refrain from taking any action which would cause interest on the Bonds to become includable in the gross income of the owners thereof.

- Voted:
- The District hereby declares its intent to finance, as needed, from its funds on hand, the costs of the Project, which costs are reasonably expected to be reimbursed with the proceeds of the Bonds, in the maximum principal amount of \$9,000,000.00. This resolution constitutes a Declaration of Official Intent by the District pursuant to Treasury Regulation §1.150-2.
- Voted:
- All actions taken to date by the Board and the officers of the District with respect to the authorization and sale of the Bonds are hereby ratified and confirmed.
- Pursuant to 1 MRSA §405 (6) (F) to enter executive session for the purpose of discussing information contained in records made, maintained or received by a body or agency when access by the general public is prohibited by statute
