VI. Town Manager's Report

I'm in the process of hiring a part-time Deputy Clerk to replace Madeline Winston.

All States Construction has completed paving Dingley Road, they have a punch list of items that need to be done to complete the road. Unfortunately, it doesn't look like Carding Machine Road will be paved this season, due to the weather.

We are waiting on an updated letter of proposal from the consultants for the recycling barn.

Mr. Delair has until November 27, 2021, to complete the required clean-up for his dangerous building. We've advertised a request for bids for the clean-up of the property, which are due November 29th. We've scheduled a special Board meeting for November 30th to award the bid. The goal is to have the required work completed by the first of the year.

The Town Hall Committee has begun meeting and discussing plans for moving forward. Besides cosmetic work we discovered that the roof leaks and needs repair as well as the foundation. We are looking at having an engineer look at the building and give us plan over everything that is needed.

The Committee has begun working on a funding plan. To kick off the fundraising:

- Bowdoinham Historical Society is offering to match up to \$5,000 in cash donations.
- The Town has sponsored a calendar to promote Bowdoinham's rich history and community. The calendar highlights the historical quilt of Bowdoinham 1912 to 2012.

The Committee is also working on a survey to gather community input on what they would like to see for Town Hall.
