An Ordinance to Amend the Town of Bowdoinham Land Use Ordinance to Add Clarifying Provisions Regarding Select Board Licensing Applications and to add Liquor Licensing Fees

Other sections of the Ordinance are unchanged.

The Town of Bowdoinham hereby ordains and enacts "An Ordinance to Amend the Town of Bowdoinham Land Use Ordinance to Add Clarifying Provisions Regarding Select Board Licensing Applications and to add Liquor Licensing Fees" to read as follows:

<u>Part 1</u>: Article 11. Section C, Subsection 6, Select Board Permit Review Procedure for administering a license is hereby amended as follows:

- b) Submission Requirements License Application Requirements
- (i) Site Plan Review Permit from the Planning Board, if applicable
- (ii) (iii) All information and fees detailed in Article 11, D) Permit Application Submission Requirements.
- (ii) (iii) All applicable State licenses/registrations and permits.
 - (A) If State licenses/registrations and/or permits have been filed but not yet granted, then the applicant must provide a copy of said application(s).
 - (B) If the applicant's application is approved by the Select Board, their approval will be contingent upon their State approvals, a copy of which must be given to the Town Clerk before business can commence.
- (iii) Burden of proof. The applicant shall have the burden of proving that the proposed project, development or land use activity is in conformity with the purposes and provisions of this Ordinance and any applicable State laws and rules.
- (iii) (iv) The applicant shall submit seven (7) copies of the application and all supporting documentation.

<u>Part 2</u>: Article 11, Section D, Subsection 2) g) Select Board Licensing Fees is hereby amended as follows:

- (iii) Liquor License & Application Fees
 - (A) <u>Initial Application fee of five hundred (\$500) dollars.</u>
 - (B) Renewal application fee two hundred and fifty dollars (\$250)
 - (C) Annual Liquor License The license fee shall be as follows:
 - (1) Restaurant with on-premises liquor sales \$200
 - (2) Catering Establishment \$200
 - (D) (D) One-time Catering Liquor License fee fifty dollars (\$50)
- (iii)(iv) Marijuana License & Application Fees

Part 3: Effective Date.

This Ordinance shall take effect upon adoption by the Town Meeting.
