Dear Town Manager:

We are committed to keeping you and our customers informed about changes to Xfinity TV services. Accordingly, please note the following changes to the Xfinity channel lineup provided in your community:

*Effective December 8, 2025, FOX programming will move from WPFO channels 7; HD 507/1023 to WGME (FOX) on channels 10; HD 509/100. WGME-ROAR will no longer be available as of December 8th.*

*Comcast's right to continue carrying channels owned by Versant on legacy video tiers expires on January 8, 2026. Effective January 8, 2026, E!, SYFY, and USA will no longer be included in legacy video tiers. These channels will still be available with Popular TV, the Sports & News genre pack (MSNBC), and the Entertainment genre pack (E!, Oxygen, SYFY, and USA).*

*The following channel locations will be moving on January 22, 2026: WGME-FOX will move from channel 10 to channel 5; CSPAN will move from channel 5 to channel 10.*

Customers are receiving notice of these changes in their bill.
