



**TOWN OF BOWDOINHAM  
2021 TAX CLUB ENROLLMENT AGREEMENT  
For July 1, 2021– June 30, 2022**

I, \_\_\_\_\_, as the owner and person responsible for the payment of annual property tax on my primary and legal residence located at \_\_\_\_\_, and identified on the Town of Bowdoinham Tax Maps as Map \_\_\_\_\_, Lot \_\_\_\_\_, in the Town of Bowdoinham, and State of Maine, do hereby enroll in the 2021 Tax Club as established by the Inhabitants of the Town of Bowdoinham at their June 9, 2021 Town Meeting, and agree to the stated terms contained herein:

1. The taxpayer agrees to pay specified monthly payments to the Town based on his/her actual tax obligation for the current year property taxes;
2. The Town agrees not to charge interest on timely payments made pursuant to the Tax Club agreement;
3. The agreement can be terminated if a scheduled payment is late and the taxpayer then becomes subject to the same due dates, interest dates, and rates as other taxpayers who are not participating in the Tax Club;
4. Only taxpayers who do not have any outstanding tax obligations for prior tax years are eligible to participate in the Tax Club program;
5. Tax Club payments begin in July and end in June. The first payment is due July 15th. The first two payments will be estimated payments and the following 10 payments will be adjusted after the tax rate is determined;
6. Tax Club payments are due on the 15<sup>th</sup> of each month;
7. The last payment and any remaining balance must be paid no later than June 30, 2021;
8. Payments may be made in person, on-line, or by mail and must be postmarked by the 15<sup>th</sup> of the month;
9. Monthly payments will be calculated by the Tax Collector’s Office and the payment coupon books will be printed after tax bills are available, normally by September 1<sup>st</sup>;
10. Two late payments without proper notification to the Town Office will result in your removal from the Tax Club, and interest will begin to accrue on the remaining outstanding balance.
