
On September 28, 2023 the Solid Waste Committee asked the citizens of Bowdoinham to provide feedback on our current trash program. The feedback was open from September 28 through October 8, 2023. The questions were posted on both the Bowdoinham Friends & Family page and the Bowdoinham Forum page. If an individual answered the questions on both pages only one of their responses is reflected in the totals below. Not all respondents responded to all three questions.

Facebook was used based on time constraints, however the respondents may not represent a statistically valid sample of the population. For example elderly citizens may not be adequately represented. For that reason trends should be considered indicative, but not definitive. However, based on the margin-of-error where the trend is significant we can be more comfortable with the result.

Outlined below are the results for each question along with select comments generally representative of all comments.

QUESTION 1:

On a sale of 1 to 5, where 1 - Very Satisfied and 5 = Very Dissatisfied; How satisfied are you with our current approach of having trash picked up roadside?

Question 1 comments:


- I believe some of the trash tag is payed by everyone's taxes. I would just like to not pay for everyone else's trash.
- We live on Beechnut Ridge. Pay taxes and are not afforded this service. (Note: curbside pick-up is provided for households on public roads, citizens who live on

private roads must bring their trash bags to the end of the private way to the public road).

- Bowdoin, bowdoinham, and Richmond should team up and have an actual dump. (Another citizen responded to this: "that was researched 4 years ago and found uncompatible (sic)")
- Partial comment from a Bowdoinham Selectman. "We are only required by state statute to provide a place for Household waste to be taken. Currently that place is Pine Tree Waste in west bath. Any resident can bring their trash there directly for a fee but requires "no trash tag". NOTE: FROM OCTOBER 4 EMAIL FROM CASELLA MUNICIPAL ACCOUNT MANAGER (Casella is parent company of Pine Tree Waste) "OUR WEST BATH FACILITY IS NOT A RESIDENTIAL DROP OFF FACILITY."

QUESTION 2:

On a scale of 1 to 5, where 1 = program should be paid 100% by Trash Tags and 5 = program should be totally supported by tax revenue please respond to the following: Do you believe the program should pay for itself entirely through trash tags or be subsidized by general taxes? Please note current self-sustaining price for trash tags if \approx \$3.60/bag. If trash take prices are reduced the difference would be made up through tax revenue.


Question 2 comments:

- Self sustaining on tags but also a taxpayer funded program to provide some tags to low income households. From my perspective I would rather pay a little extra in taxes than to have trash all over the roadside. So if the option is pay extra in taxes or watch a bunch of people justify duping their trash on our roads, I would rather pay the extra and have a nice town.
- Increase the cost of the tags so that it actually covers the new expense.

- If tags are required, it should be 100% paid by the tags. If taxes are covering it, it should be free.
- I'm just afraid that if it's all paid for by taxes people will tend to throw more and more stuff in the trash, which could cause costs to go way up. On the other hand, when we can see how much we're paying for each bag as we fill it, we may pay more attention to recycling and re-using, which helps keep stuff out of the landfill and thus helps keep costs down.
- The program should be self sustaining and not use tax revenue. It is easy to calculate ... There should be an avenue to have it automatically inc/dec yearly based on the previous year.

Question 3 comments:

- I'd be willing only if it were free and could be brought at any time/any day with no restrictions on quantity.
